Committee Reports – Appendix 1

USC System Faculty Leadership Council

Kim Kelley: The SFLC met on March 7th.

Introducing a new member: Cheryl Addy is a new member of SFLC for USC Columbia. Professor Addy is currently the chair of the College of Nursing.

Ombuds: Professor Addy was previously in administration and was involved with the faculty ombuds. She indicated that the policy had changed in 2022 to have the ombuds position focus on USC Columbia only. The SFLC will hear from VP Julian Williams at its next meeting in April on what the current policy is and whether the USC Columbia ombuds could be available to other USC campuses except Upstate who have their own ombuds. As a reminder, VP Williams stated that faculty from other USC campuses could reach out to him if they have an issue they think would benefit from a discussion with an ombuds. The SFLC will also ask VP Williams the reasoning behind the policy change in 2022 to remove access to other USC campuses to the USC Columbia ombuds.

Legislative Update: The USC campuses have been following the DEI legislation in the House: South Carolina Bill 3927. The group was interested in the status, and whether their campus chancellors were speaking to them about the bill and its status. Some USC campuses are receiving information from their chancellors. The bill is not yet in the Senate. The campuses are waiting to see if the bill progresses to the Senate.

Dear Colleague Letters: Several campuses have been impacted by the Department of Education's "dear colleague letter." USCB's education department's grant was defunded. USCB is currently appealing the decision. Faculty are encouraged to look at several documents to get more familiar with the implications of these letters including: <u>Frequently Asked Questions</u> from the Department of Education and a <u>memorandum signed by law professors regarding DEI programs</u>.

Distance Education Policies. The SFLC reviewed the report by a sub-committee on policies regarding how many courses USC faculty may teach across the system. The group decided that the variability was appropriate for the various campuses based on specific needs and no action by SFLC was needed.

Honors Steering Committee (Ad hoc)

Mac James: The Honors Steering Committee met on Feb. 25, 2025. We discussed changes to the Honors Student Handbook, Honors applications from current students and Honors admission criteria for incoming Freshmen (Fall 2026). We ask senators to please share the following information with your departments.

- HSC received 67 Honors Contract proposals this spring with students working with 32 different faculty members. HSC approved 66 Honors Contracts.
- HSC has dismissed 1 student and placed 26 others on probation after Fall 2024 grades were submitted (as of Spring 2025 there are 159 Honors students).
- Current HSC membership includes Mercer Brugler, Jo Kuehn, Davide Fusi, Babet Villena-Alvarez, Kim Dudas, Gary Sutton and Mac James.
- Honors continues to be a powerful retention tool, boasting a 6-year retention of 55%, compared to the institutional rate of 39% as of October 16, 2024.

International Programs Committee (Ad hoc)

Kyle Messick: We have 56 Internationals as of Jan 15, 2025, from 25 countries (8 India, 5 Jamaica, 5 UK, 4 Norway, 4 Sweden, 3 Venezuela, 3 Honduras, 3 Canada, etc.). Most of them are athletes.

IPC Meeting Feb 26, 2025 – Michael Weiss reported that some had reached out to him with concerns regarding being able to return after summer with current political climate; he mentioned issues with Venezuela in particular.

Study Away: South Dakota (NURS, Lynne H), Florida (partly funded -HRTM, Sean Barth, Kim D)

Fulbright student scholars – session with Kim C, sometime April. We may provide an update on this since the situation with Fulbright has gotten complicated following funding freezes and the disbanding of federal departments that play a role in the dispersion of those funds.
