The USCB Athletic Mark Suite gives a visual image to the university mascot. The Sand Shark spirit symbols represent the athletic programs, the university's tie to the Lowcountry, and its developing identity as a distinct baccalaureate degree granting institution. This logo suite is an important tool for building campus and community spirit.

The USCB Athletic Marks are designed to create a consistent brand for the USCB Sand Sharks. At the same time, there are many variations from which to choose. Thus, there should be a design compatible with any application. The preferred logo is the primary

OFFICIAL COLORS

USCB Navy, Sand, and Intracoastal Blue are the official colors of the USCB Sand Shark identity system. USCB's primary color is Navy (PMS 282 C); the secondary color is Sand (PMS 466 C), and the tertiary color is Intracoastal Blue (PMS 631 C - at 90% value). It is extremely important to match the USCB colors faithfully. The USCB Intracoastal Blue may be especially challenging to replicate, but it is critical that it be matched as closely as possible.

SAFE ZONES

Each of the USCB Sand Shark logos has an established safe zone. This safe zone is intended to maintain the logo's integrity and to avoid visual confusion. No other type or graphic element (including folds, trims, or edges) should fall within the safe zone shown. The safe zone for most horizontal USCB Sand Shark logos is equal to one fifth of the height of the logo (A).

The safe zone for the more square USCB Sand Shark logos is equal to one eighth of the height of the logo (B). This safe zone spacing is uniform on all sides of the logo.











LOGO VIOLATIONS

Never angle or rotate any USCB Sand Shark logo



Never present or write the "Sand Shark" identity as one word. The USCB mascot name is always two words with both words capitalized.
